What can you give?

Planned giving allows you to take advantage of numerous philanthropic, tax, financial, and estate planning benefits. Your gift can be in many forms – cash, stock, mutual funds, real estate, insurance, art or other personal property.

How can you give?

There are many ways to make a gift, including:

A Gift of Cash

A Gift of Property – This might include a residence, other real estate, a piece of artwork or other personal property.

A Bequest – Your gift can take many forms, including cash, securities, or real property. You can specify a specific dollar amount or item; a percentage of your estate; a part of your residuary estate; or a contingent gift. An example of the gift language in your will is: "I give, devise and bequeath to Western Center on Law and Poverty (tax ID number 95-2897721), a nonprofit, charitable organization in Los Angeles, CA _____ dollars/ ___ percentage of my estate/all of the residue of my estate."

Life Insurance; Retirement, Savings and Brokerage Accounts – Western Center can be named as a beneficiary on your life insurance policy, IRA or other retirement plan, savings account or stock account.

Other Options – There are many creative ways to structure your giving to provide the greatest impact to Western Center, while maximizing the tax and estate planning benefits to you and your family. These include Charitable Gift Annuities, Charitable Lead Trusts, Charitable Remainder Trusts and Retained Life Estates.
