

**Human Services and Access to Jobs & Justice Legislation  
October 16, 2017**

The deadline for Governor Jerry Brown to take action on legislation passed in 2017 was October 15. Below is a list of Human Services and Access to Jobs & Justice legislation that we were tracking and the outcome of these bills. If Western Center has taken a position, it is also listed.

***CalFresh, Emergency Food, Food System and School Meal Legislation***

[SB 138 \(McGuire\)](#) would require the state and all school districts to utilize Medi-Cal Direct Certification to enroll students in the federal school meal programs, and for the highest-poverty schools to offer free breakfasts and lunches to all students through a federal universal meal provision. **Location: Signed by the Governor, Chapter 724, Statutes of 2017.**

**Position: Support**

[SB 250 \(Hertzberg\)](#) would establish state standards to prevent harmful treatment to school children when their families are unable to pay an unpaid debt to the school food services providers. Co-Sponsored by Western Center, the Children's Defense Fund, Coalition of California Welfare Rights Organizations, MAZON: A Jewish Response to Hunger and the Food Research and Action Center.

**Location: Signed by the Governor, Chapter 726, Statutes of 2017.**

**Position: Co-Sponsor & Support**

[SB 278 \(Wiener\)](#) would require the Department of Social Services to establish a cost-effective threshold for their collection of CalFresh overissuances when they were not caused by a client's intentional error or fraud and would require counties to report when mass overissuances were made as a result of county systems failure or negligence. Co-sponsored by Western Center and the Coalition of California Welfare Rights Organizations.

**Location: Signed by the Governor, Chapter 388, Statutes of 2017.**

**Position: Co-Sponsor & Support**

[SB 282 \(Wiener\)](#) would codify the CalFresh Restaurant Meal Program (RMP) for elderly, disabled or homeless recipients in state law. It would also require the Department of Social Services to seek approval for a CalFresh Employment & Training subsidized job program. Co-sponsored by Western Center on Law and Poverty, the County Welfare Department Association and the Coalition of Welfare Rights Organizations.

**Location: Signed by the Governor, Chapter 355, Statutes of 2017.**

**Position: Co-Sponsor & Support**

[SB 557 \(Hernandez\)](#) would allow for food from a school cafeteria that has been untouched or unspoiled can be donated to a food bank or another emergency food provider.

**Location: Signed by the Governor, Chapter 285, Statutes of 2017.**

[SB 675 \(Skinner\)](#) would ensure adequate customer service for people purchasing food using Electronic Benefit Transfer (EBT). This bill is co-sponsored by Western Center, United Food and Commercial Workers Western State's Council and the California Grocers Association.

**Location: Assembly Floor – Placed on Inactive File – Two Year Bill**

**Position: Sponsor & Support**

[SB 708 \(Skinner\)](#) would improve access for people leaving prison to CalFresh anti-hunger assistance and to Supplemental Security Income (SSI). Co-sponsored by Western Center, Root & Rebound, County Welfare Directors Association (CWDA) and the Ella Baker Center and the Los Angeles Regional Reentry Partnership. **Location:** Two Year Bill

**Position:** Co-Sponsor & Support

[AB 164 \(Arambula\)](#) would establish a new chapter in Welfare and Institutions code which would provide for a state funded anti-hunger CalFresh benefit to be issued under prescribed circumstances, such as drought, disaster or in the case of federal SNAP ineligibility, and to be issued using the EBT system. **Location:** Senate Appropriations Suspense File – Held in Committee

**Position:** Support

[AB 167 \(Lackey\)](#) would establish require the Department and County Human Services Agencies to use a blank semiannual report form as the certificate of eligibility for the purposes of CalWORKs and CalFresh. Sponsored by the Coalition of California Welfare Rights Organizations.

**Location:** Two Year Bill

[AB 214 \(Weber\)](#) would address college student hunger by defining terms used in the CalFresh program to determine eligibility and clarifying law concerning CalFresh Restaurant Meal Program on College Campuses. Co-Sponsored by Western Center, Young Invincibles, Coalition of California Welfare Rights Organizations and the CSU Student Association.

**Location: Signed by the Governor, Chapter 134, Statutes of 2017.**

**Position:** Co-Sponsor & Support

[AB 323 \(Berman\)](#) would amend current law that requires a county to provide a written list of emergency food providers to CalFresh applicants who request it by allowing a county to, instead, provide a 211 referral. **Location: Signed by the Governor, Chapter 68, Statutes of 2017**

**Position:** Sponsor & Support

[AB 453 \(Limón\)](#) would combat college student hunger by establishing a Hunger Free Campus designation to encourage colleges to implement several promising practices, such as: on-campus food distributions, meal plan fund donations, and CalFresh education. This bill is co-sponsored by Western Center, Young Invincibles and SWIPE Against Hunger.

**Position:** Co-Sponsor & Support

[AB 563 \(Arambula\)](#) would establish that someone subject to the Able-Bodied Adult without Dependents (ABAWD) 3-month time limit and related work requirement cannot also be required to work in a mandatory CalFresh E&T Program as a condition of eligibility. Clarifies that the Department of Social Services may prioritize use of federal CalFresh E&T funding to achieve equity goals and may contract directly with an E&T Provider.

**Location: Signed by the Governor, Chapter 343, Statutes of 2017.**

**Position:** Sponsor & Support

[AB 607](#) ([Gloria](#)) would add the Disaster CalFresh Program into statute and establish various requirements of the Department of Social Services and County Human Services Agencies to improve disaster planning and response. Co-sponsored by Western Center, CA Association of Food Banks & Jacobs & Cushman San Diego Food Bank.

**Location:** Signed by the Governor, Chapter 501, Statutes of 2017.

**Position:** Co-Sponsor & Support

[AB 625](#) ([Quirk-Silva](#)) would require the Department of Social Services to submit a waiver to the USDA pertaining to eligibility of foster youth residing in an institutional setting.

**Location:** Two Year Bill

**Position:** Support

[AB 1219](#) ([Eggman](#)) would clarify and strengthen the rights of people recovering food, gleaners, or food facilities to donate food without fear of civil or criminal liability relating to the donated food.

**Location:** Signed by the Governor, Chapter 619, Statutes of 2017.

**Position:** Support

### ***Economic Empowerment & Access to Jobs and Justice***

[SB 6](#) ([Hueso](#)) This bill would improve access to qualified nonprofit legal services professionals for Californians who are detained in removal proceedings and not otherwise entitled to legal representation under an existing local, state, or federal program.

[SB 10](#) ([Hertzberg](#)) / [AB 42](#) ([Bonta](#)) would reform the money bail system, which discriminates against people who cannot afford bail, to ensure that everyone presumed innocent has the ability to secure a pre-trial release. This bill is co-sponsored by Western Center, the American Civil Liberties Union of California, the Anti-Recidivism Coalition, California Public Defenders Association, Californians for Safety and Justice, Ella Baker Center for Human Rights, Essie Justice Group, SEIU California, and the Silicon Valley De-Bug. **Location:** Two Year Bill

**Position:** Co-Sponsor & Support

[SB 16](#) ([Wieckowski](#)) would establish a reduced maximum amount that can be garnished of earnings when any part of the order is based on a claim for debt on a student loan that is not made, insured, or guaranteed by the United States Government pursuant to the Federal Family Education Loan Program or the William D. Ford Federal Direct Loan Program.

**Location:** Assembly Floor – Eligible for reconsideration in 2018

**Position:** Support

[SB 185](#) ([Hertzberg](#)) would prevent the automatic suspension of driver's licenses for people who are unable to pay fines or fees for minor traffic tickets and require courts to determine violators' ability to pay before setting fine amounts. This bill is co-sponsored by Western Center, American Civil Liberties of California, East Bay Community Law Center, and Lawyers Committee on Civil Rights of the San Francisco Bay.

**Location:** Assembly Appropriations Suspense – Hearing Postponed

**Position:** Co-Sponsor & Support

[SB 190](#) ([Mitchell](#) and [Lara](#)) would remove the law that allows probation departments to collect administrative fees from parents whose children have been placed in juvenile detention or on probation. Co-sponsored Anti-Recidivism Coalition, Center on Juvenile and Criminal Justice, East Bay Community Law Center, Insight Center

for Community Economic Development, Fathers and Families of San Joaquin, Lawyers Committee on Civil Rights of the San Francisco Bay Area, PolicyLink, Public Counsel, RYSE Youth Center Richmond, W. **Location: Signed by the Governor, Chapter 678, Statutes of 2017.**

**Position:** Co-Sponsor & Support

[SB 298 \(Wieckowski\)](#) will cap how much can be levied from a bank account at one time to ensure that basic needs of the consumer can be met. It does not relieve the consumer of the debt. The bill is co-sponsored by Western Center and the California Low-Income Consumer Coalition.

**Location:** Assembly Floor – Eligible for reconsideration in 2018

**Position:** Co-Sponsor & Support

[SB 310 \(Atkins\)](#) would entitle currently incarcerated trans-people to the right to apply for a legal name and gender marker change on their identifying documents and to have the decision about whether or not to approve the change made by the Superior Court, rather than a warden. This bill is sponsored by the Women's Policy Institute.

**Location: Signed by the Governor, Chapter 856, Statutes of 2017.**

**Position:** Support

[SB 491 \(Bradford\)](#) would clarify that local municipal governments can investigate and enforce employment discrimination with an MOU established with the CA Department of Fair Employment and Housing.

**Position:** Support

[SB 775 \(Wieckowski\)](#) would modify California's cap and trade program by steadily increasing the price on pollution credits beginning in January 2021 and create a dividend fund in order to return some revenue from the program directly to households protecting households from the effects of price increases while still motivating emissions reductions.

**Location:** Two Year Bill

**Position:** Support

[SB 614 \(Hertzberg\)](#) would ensure that public transit agencies receive revenue from fare evasion tickets. Co-sponsored by the Western Center and California Transit Association.

**Location: Signed by the Governor, Chapter 219, Statutes of 2017**

**Position:** Sponsor & Support

[AB 5 \(Gonzalez Fletcher\)](#) would require an employer with 10 or more employees to offer additional hours of work to an existing nonexempt employee before hiring an additional employee or subcontractor.

**Location:** Two Year Bill

[AB 9 \(Garcia\)](#) would exempt menstrual hygiene supplies from state sales tax.

**Location:** Two Year Bill

**Position:** Support

[AB 10 \(Garcia\)](#) would require that school bathrooms offer an adequate supply of free menstrual supplies in Title 1 Schools grades 6-12.

**Location: Signed by the Governor, Chapter 687, Statutes of 2017.**

**Position:** Support

[AB 17 \(Holden\)](#) would create the Transit Pass Program that would fund some free transit passes for high school, community college, and University of California or California State University students.

**Location:** Vetoed by Governor

**Position:** Support

[AB 21 \(Kalra\)](#) would establish several rights to protect students at public colleges from various hardships and increasing likelihood of graduation.

**Location:** Signed by the Governor, Chapter 488, Statutes of 2017.

[AB 34 \(Nezarian\)](#) would establish The Children's Savings Account Program, a universal, at-birth, statewide 529 children's savings account program to ensure California's children foster a college-bound identity and practice education-related financial planning.

**Location:** Two Year Bill

[AB 43 \(Thurmond\)](#) would impose a tax on companies that profit from contracting with a state prison, the Department of Corrections and Rehabilitation, or the Department of General Services to provide a state prison with goods and services. It would use the tax revenue to support programs and services that would reverse the cradle to prison pipeline.

**Location:** Two Year Bill

**Position:** Support

[AB 60 \(Santiago\)](#) would require eligibility redetermination periods for subsidized child care to be set for not less than 12 months, limit mandatory reports during the eligibility period, and revise eligibility rules related to income eligibility. Co-sponsored by Parent Voices of California and the Childcare Law Center.

**Location:** Two Year Bill

**Position:** Support

[AB 90 \(Weber\)](#) would make reforms to the development and use of a "gang database," based on the fact that these databases have been proven to be significantly flawed in their methodology, which includes naming people simply based on where they live, who is in their family and what they wear.

**Location:** Signed by the Governor, Chapter 695, Statutes of 2017.

**Position:** Support

[AB 204 \(Medina\)](#) would require regular review of the local appeals processes for the California Community College Board of Governor's (BoG) fee waiver for low-income students, focusing on whether students have sufficient due process to address their claims. It would also add geographic barrier as a basis for an appeal of the loss of a BoG fee waiver. Finally, it would require a local Community College Districts to regularly review whether new academic new standards have disproportionately impacted vulnerable populations and to address issues related to a disproportionate impact in their Student Equity Plans.

**Location:** Senate Appropriations Suspense, Held in Committee

**Position:** Support

[AB 225 \(Caballero\)](#) would allow more working families to qualify for California Earned Income Tax Credit. The bill would open eligibility to full-time minimum wage earners and will also adjust the minimum wage increase through 2020. Monies allocated for the increased credit will directly stimulate our state's economy by allowing California families to re-invest this credit through the purchase of taxable goods and services.

**Location:** Two Year Bill

[AB 273 \(Aguilar-Curry\)](#) would improve access to child care while parents attend ESL and GED classes. This bill is sponsored by the Women's Policy Institute of the Women's Foundation.

**Location:** Signed by the Governor, Chapter 689, Statutes of 2017.

**Position:** Support

[AB 412 \(Ting\)](#) would require the court to vacate a civil assessment imposed pursuant to specified provisions, if the defendant certifies that he or she had good cause to not appear or not pay a fine, or is unable to pay the assessment. This bill is co-sponsored by American Civil Liberties Union of California and Western Center.

**Location:** Two Year Bill

**Position:** Sponsor & Support

[AB 503 \(Lackey\)](#) would permit a person to register their car even if they had unpaid parking tickets.

**Location:** Signed by the Governor, Chapter 741, Statutes of 2017.

**Position:** Sponsor & Support

[AB 569 \(Gonzalez-Fletcher\)](#) would protect employees who work in California from workplace discrimination based on their personal reproductive health care decisions. This bill is co-sponsored by NARAL and California Latinas for Reproductive Justice (CRLJ).

**Location:** Vetoed by the Governor

**Position:** Support

[AB 620 \(Holden\)](#) would increase access to trauma-focused programming for people in prison and help them to understand and communicate to the parole board how the trauma they experienced relates to their conviction.

**Location:** Two Year Bill

**Position:** Support

[AB 784 \(Dababneh\)](#) would, once amended, would impose a rate cap of approximately 21% for loans \$2,500 - \$5,000. In addition, the bill would extend the California Responsible Small Dollar Loan Pilot to loans up to \$5000. The pilot program allows for higher rates but requires underwriting and includes other consumer protection requirements. It will also eliminate the pilot sunset. **Location:** Two Year Bill

[AB 1008 \(McCarty, Holden, Weber, Gipson, Reyes\)](#) would provide it is an unlawful practice for an employer to include on an application for employment any question that seeks disclosure of an applicant's criminal history.

**Location:** Signed by the Governor, Chapter 789, Statutes of 2017.

**Position:** Support

[AB 1010 \(Ting\)](#) would maximize the CalEITC's impact in reducing poverty and increasing economic security by expanding to align with the federal EITC, including self-employed workers.

**Position:** Support

[AB 1106 \(Weber\)](#) would permit the Superintendent of Public Instruction to create a contracting process to permit Alternative Payment Programs (APPs) to expend their yearly allocated monies over 36 months.

**Location:** Signed by the Governor, Chapter 716, Statutes of 2017.

**Position:** Support

[AB 1109 \(Kalra\)](#) would require that would cap loans between \$2,500 and \$10,000 at 24%. This bill is sponsored by Ntl Council of La Raza (NCLR) & Coalition for Humane Immigrant Rights of L.A. (CHIRLA).

**Location:** Two Year Bill

**Position:** Support

[AB 1099 \(Gonzalez Fletcher\)](#) would require a service sector employer that accepts credit card payments to also allow for payments of tips using a credit card.

**Location:** Two Year Bill

**Position:** Support

[AB 1164 \(Thurmond\)](#) provides for an emergency child care bridge program for foster children and parenting foster youth by assisting with vouchers for resource families to access child care, navigators to assist families

with accessing long-term child care, and training for child care providers on how to best meet the needs of abused and neglected children.

**Location:** Two Year Bill

**Position:** Support

[AB 1469 \(Grayson\)](#) would improve access to school transportation services for low-income students, increasing their capacity to regularly participate in school and increasing the likelihood of graduation and lifelong success. Co-sponsored by Western Center, Children's Defense Fund and Youth Justice Coalition.

**Location:** Two Year Bill

**Position:** Co-sponsor and Support

### ***CalWORKs, SSI, General Assistance and Child Support***

[SB 164 \(McGuire\)](#) would give recipients of Tribal TANF the same California Community College early enrollment entitlement that CalWORKs recipients have.

**Location:** Signed by the Governor, Chapter 97, Statutes of 2017

**Position:** Support

[SB 232 \(Bates\)](#) would require the State Department of Social Services to design and implement a pilot project to provide grants to organizations operating programs that CalWORKs recipients.

**Location:** Two Year Bill

**Position:** Support

[SB 360 \(Skinner\)](#), as amended, would establish that any amount of overissuance that happened after the county should have acted on an EIVES report (as defined in federal law) shall be counted as a county error. Sponsored by the Coalition of California Welfare Rights Organizations.

**Location:** Signed by the Governor, Chapter 390, Statutes of 2017.

**Position:** Support as Amended

[SB 380 \(Bradford\)](#) would allow, at the option of the head of household, a step or half-sibling to have their needs excluded from consideration in calculating the family's CalWORKs grant if the child support received for the child is more than the child's portion of the benefit.

**Location:** Signed by the Governor, Chapter 729, Statutes of 2017.

**Position:** Sponsor & Support

[SB 469 \(Skinner\)](#) would end the sunset on the low-income adjustment for child support payment calculations. Co-sponsored by Western Center and the Coalition of California Welfare Rights Organizations.

**Location:** Signed by the Governor, Chapter 730, Statutes of 2017. **Position:** Sponsor & Support

[SB 570 \(Newman\)](#) clarifies that income derived the Veterans Administration for disability, GI Bill or survivor benefits shall be exempt from income in CalWORKs.

**Location:** Signed by the Governor, Chapter 463, Statutes of 2017.

**Position:** Sponsor & Support

[AB 85 \(Rodriguez\)](#) which would require counties to exempt veterans from time limits in County General Assistance or General Relief Programs. Sponsored by the Ca. of California Welfare Rights Organizations.

**Location:** Two Year Bill

**Position:** Support

[AB 160 \(Stone\)](#) would increase CalWORKs Earned Income Disregard & restore lifetime eligibility to 60 months.

**Location:** Two Year Bill

**Position:** Co-Sponsor & Support

[AB 210 \(Santiago\)](#) would authorize counties to establish coordinating teams for homeless adults, children and families to improve coordination between, and expedite access to, housing and supportive services.

**Location: Signed by the Governor, Chapter 544, Statutes of 2017.**

[AB 227 \(Mayes\)](#) would establish a grant supplement for CalWORKs recipients who achieve educational benchmarks. Co-sponsored by Western Center and the Coalition of California Welfare Rights Organizations. Funding for CalWORKs education support and incentive grants were included in the Budget Act of 2017-18. **Position:** Co-Sponsor & Support

[AB 236 \(Maienschein\)](#) This bill would make improvements to the CalWORKs Temporary Homeless Assistance Program. It is co-sponsored by Western Center, the County Welfare Directors Association and the Coalition of California Welfare Rights Organizations.

**Location: Signed by the Governor, Chapter 545, Statutes of 2017.**

**Position:** Co-Sponsor & Support

[AB 415 \(Chiu\)](#) would clarify that the Department of Social Services and Counties can work with a social enterprise entities in for CalFresh Employment and Training and CalWORKs subsidized jobs. This bill is co-sponsored by Western Center and The Roberts Enterprise Development Fund (REDF).

**Location: Signed by the Governor, Chapter 340, Statutes of 2017.**

**Position:** Co-Sponsor & Support

[AB 480 \(Gonzalez Fletcher\)](#) would establish diaper benefit low-income parents participating in the CalWORKs welfare-to-work program includes diapers for infants and toddlers.

**Location: Signed by the Governor, Chapter 690, Statutes of 2017.**

**Position:** Support

[AB 557 \(Rubio\)](#) would require counties to waive CalWORKs rules that were unfair to a survivor of domestic abuse or would make it more difficult for them to avoid violence. This bill is co-sponsored by Western Center, the California Partnership to End Domestic Violence, the Coalition of California Welfare Rights Organizations, Latinas for Reproductive Justice and In Our Own Voice: National Black Women's Reproductive Justice Agenda.

**Location: Signed by the Governor, Chapter 691, Statutes of 2017.**

**Position:** Co-Sponsor & Support

[AB 796 \(Kalra\)](#) would reinstate the cost-of-living adjustment (COLA) for the SSI/SSP benefit (beginning January 1, 2018) and require a maximum aid payment that would increase incrementally until January 1, 2019, when it would be set at 100%. This bill is co-sponsored by Western Center, California Partnership and other members of the Californians for SSI Coalition.

**Location:** Two Year Bill

**Position:** Co-Sponsor & Support

[AB 818 \(Burke\)](#) would entitle a CalWORKs recipient to receive an extension of the 24 month time limit if they are working toward their H.S. diploma or its equivalent or have received one through participating in their Welfare-to-Work plan. This bill is sponsored by the County Welfare Directors Association (CWDA).

**Location: Signed by the Governor, Chapter 141, Statutes of 2017.**

**Position:** Support

[AB 910 \(Ridley-Thomas\)](#) is a spot bill related to the two-parent penalty in CalWORKs eligibility determination that impacts parents who are working. It is co-sponsored by Western Center and the Coalition of California Welfare Rights Organizations.

**Location: Signed by the Governor, Chapter 318, Statutes of 2017.**

**Position:** Co-Sponsor & Support

[AB 992 \(Arambula\)](#) would establish the CalWORKs Baby Wellness and Family Support Home Visiting Program, a voluntary public health home visiting program to serve pregnant women and families with infants and



toddlers in order to improve the health and family outcomes of children born into deep poverty. This bill is co-sponsored by Western Center and the Children's Defense Fund of California.

**Location:** Two Year Bill

**Position:** Co-Sponsor & Support

[AB 1604 \(Nazarian\)](#) This bill would provide that if a CalWORKs recipient has not received his or her high school diploma or its equivalent, he or she may participate in a high school equivalency program instead of participating in a job search or job club and prohibit the county from requiring the recipient to participate in an assessment before the recipient of their degree or equivalency. It is co-sponsored by Western Center and the Coalition of California Welfare Rights Organizations.

**Location:** Signed by the Governor, Chapter 343, Statutes of 2017.

**Position:** Co-Sponsor & Support
