



This week the Legislature returned from Spring Recess. As the deadline for bills with fiscal cost to pass out of policy committee for house of origin looms on April 28, many bills have been given additional depth and substance as they undergo their first policy committee hearing. Following is a summary of bills in the Legislature that affect the health of low-income Californians.

Climate change remediation includes devices and installation of those devices to address health-related complications, barriers, or other factors linked to extreme weather or other climate events. Assembly Appropriations	The bill would require the Department to seek federal approval to make housing support services a Medi-Cal benefit for Californians experiencing homelessness.
